



One (1) year limited materials warranty for interior use

INVISIBLE® Acoustic Ceilings Scandinavia Ltd hereinafter referred to as INVISIBLE®, hereby warrants, that the VISIBLE® Acoustic Spray manufactured and sold by INVISIBLE® when applied in accordance with the current specification sheets, shall be free from defects in the manufacture of the materials and will not, as a result of such defects peel, flake, delaminateor fade with the exception of certain special colors within a period of (1) year of completion of the project. However, no such warranty stated herein shall be effective until and unless the materials subject to this warranty shall have been paid in full.

It is specially understood and agreed that no warranty whatsoever is made with respect to:

- Materials produced by other manufacturers and not bearing VISIBLE®'s name or logo which are used in the application of VISIBLE®'s materials hereunder
- Surfaces to which VISIBLE® is applied

Most surface materials change color over time. In general, changes in the shades of surface materials are substantially affected by prevailing conditions, e.g., air humidity, air currents near the surface, and UV light, or the interactions of all of these. Further this warranty is void if bright white acoustical spray's tone of the color might have changed during the years without becoming uneven, the VISIBLE® materials are intermixed with other additives, chemicals or materials not specially required by VISIBLE®'s specifications or if the VISIBLE® Acoustic Spray finish is applied to any other substrates other than recommended by INVISIBLE®.

Further no warranty whatsoever is made for damages caused in whole or in part by wear and tear, accidental damage, impact damage or acts of God or natural phenomenon, such as but not limited to foreign objects, fire, earthquake, floods, pests, chemical fumes in the atmosphere, nor architecture, engineering, defective or improper workmanship by the applicator, aesthetics, nor other damage or injury not solely and directly caused by defects in VISIBLE®'s materials as covered under this warranty.

This constitutes the entire warranty agreement and INVISIBLE® makes no other warranties expressed or implied with respect to material except as expressly stated herein.

INVISIBLE® DOES NOT MAKE ANY WARRANTY OF MERCHANTABILITY WITH RESPECT TO THE MATERIALS DESCRIBED HEREIN OR THE APPLICATION THEREOFAND FURTHER, INVISIBLE® MAKES NO WARRANTY THAT THE MATERIALS ARE FIT FOR ANY PARTICULAR PURPOSE.
